- Conducting ongoing evaluations of training programs to adjust implementation.

The assignment will be estimated 120 professional staff-months and also non-key expert as required mentioned in the TOR, implementation period will approximately 24 months, expected start date of assignment may be 15 July, 2021 to ensuring full consistency with the TOR.
